RESULTS OF JUPITER FARMS ROADWAY IMPROVEMENT PROJECT REFERENDUMS

At a regular board meeting conducted prior to the annual meeting on September 21, the Board of Supervisors accepted the certified results of the referendums for the application of open-graded emulsified mix (OGEM) to 68 roadways. Of the 68 roadways, 28 passed and 40 failed. The 28 roadways that passed are as follows:

- 150th Court N between 133rd to the West End Canal
- 189th Court N between Old Indiantown Rd. and 125th Ave. N
- 110th Ave. between Sandy Run and 150th Court N
- 153rd Court N between 110th Ave. N and 115th Ave. N
- 111th Terrace between 150th Court N and 154th Road N
- 93rd Lane N between 150th Court N and 154th Road N
- 158th Street N between 133rd Terrace N and West Perimeter Canal
- 150th Court N between 125th Avenue N and 128th Terrace N
- 126th Terrace N between 164th Court N and Randolph Siding Rd.
- 156th Street N between 133rd Terrace N and West Perimeter Canal
- 123rd Terrace N between Randolph Siding Road and 164th Court N
- 158th Street N between 110th Ave. N and 105th Avenue N
- 150th Court N between 129th Terrace N and 133rd Terrace N
- 169th Court N between Mellen Lane and 130th Ave. N
- 159th Street N between 133rd Terrace N and West Perimeter Canal
- 153rd Court N between 105th Ave. N and 110th Ave. N
- 175th Road N between Mellen Lane and 130th Ave. N
- 189th Court N between 120th Terrace N and 125th Ave. N and 125th Ave. N between Old Indiantown Road and 189th Court N
- 154th Road N between 115th Ave. N and 111th Terrace N
- 179th Road N between Mellen Lane and 130th Ave. N
- 127th Drive N between 165th Road N and 169th Court N
- Rocky Pines Road from Indiantown Road south to the end, including 172nd Place N
- 170th Court N between Alexander Run and Mellen Lane
- 155th Place N between 133rd Terrace N and West Perimeter Canal
- 103 Terrace N between Indiantown Road and Canal 2
- 126th Terrace N between 185th and 187th Street N
- 129th Terrace N between Randolph Siding Rd. and Sandy Run
- 121st Terrace N between 175th Road N and 179th Court N

These roads comprise approximately 14 miles of new OGEM surface within the District.

The first of two public hearings on the Jupiter Farms Roadway Improvement Project was held on October 19. All affected landowners received notice of the hearing through first-class mail as required by Florida statutes. After a review by District Engineer Lennart Lindahl, Jr., and comments from landowners in attendance, the public hearing was adjourned. At their monthly meeting following the hearing, the board voted to authorize the District Engineer to prepare the plan of improvements for the project. A second public hearing will be scheduled within 60 days of the filing of the Engineer's plan.

In other business, the Board of Supervisors directed the District Engineer to proceed with defining benefited areas and costs in preparation for a referendum on the construction of Palm Beach County standard asphalt roadways that have been petitioned for in Palm Beach Country Estates.

Tom Rice and Dave Beane Re-elected to Board of Supervisors



Tom Rice and Dave Beane have been re-elected to three-year terms on the Board of Supervisors of SIRWCD. Dave Beane has served on the board since 1988 and Tom Rice since 1989. Rice currently serves as vice president of the Board.

Certified totals from the Supervisor of Elections office show that Beane received 1,173 votes, while Rice received 1,104 votes. They were unopposed in the election.

Palm Beach Country Estates Potable Water Project Update

Installation of the Palm Beach Country Estates (PBCE) potable water project has begun. The horizontal directional drilling of the water main under I-95 and the Turnpike has been completed, as well as the water main installation behind Egret Landing east to Indian Creek Parkway and the tie-in to the Town of Jupiter water system.

The water main and services along 159th Court North have been installed and surveying and marking for line installations is underway in a number of other areas in Section 9, north of 159th Court North.

Water service location forms for individual water service to each property
